With that in mind, we had a busy year both on and off campus. Here are a few of the highlights:

- August 2021 marked the start of our joint research project with Creighton University. Through this study we have been researching the effects of hippotherapy on children with autism.**
- In fall of 2021, we launched our Miniature Horse Onsite Learning Program. HETRA's team of therapists developed a social-emotional learning curriculum which included important topics such as communication, boundaries, and teamwork, as well as health and nutrition. This program gives HETRA the opportunity to reach more individuals in underserved areas within our community. We look forward to expanding our reach and serving even more schools next year.**
- 2021 included exciting collaborations for our Equine-Assisted Learning and Equine-Assisted Mental Health Programming with organizations such as Omaha Street School, Rejuvenating Women, Angels Among Us and Make-a-Wish Foundation.**
